NO HORSE MAY LEAVE THE GROUNDS WITHIN 24 HOURS OF THE DAY OF THEIR RACE OR BE SUBJECT TO  
PENALTY.

ALL HORSES MUST HAVE BOTH CURRENT COGGINS TEST'S AND ELECTRONIC ELIGIBILITIES

ONLY CONDITIONED HORSES ARE ALLOWED TO ENTER IF IN-TO-GO

All trainers AND designated trainers must have NYS COMP. INSURANCE.

IF YOU STABLE HERE & THERE IS A CLASS FOR YOUR HORSE, YOU MUST  
RACE HERE OR FACE POSSIBLE STALL REDUCTION.
